Commissioner Schafer shared that she attended a law and courts meeting today where they passed a few grant opportunities that will help the Sheriff's Department and approved the hiring of a new Animal Control Director. Commissioner Schafer shared she had an allergic reaction to a bee sting today and rather than drive herself to the hospital she drove herself to NIESA, Director Yanz was on duty to assist at NIESA Fire & Ambulance Station #61 where they evaluated her emergency and prepped her for a ride to the local hospital. MSUFCU Certificate of Deposit #1 - Matures 12/2/2023 - \$100,000.

--General Fund Money – Reinvest or Cash Out—Mr. Henley shared in discussions with Director Yanz and NIESA Office Manager, it is recommended MSUFCU Certificate Deposit #1 in the amount of \$100,000 be moved to Action, as Action Item A at the November 9, 2023, NIESA board meeting.

MSU Certificate of Deposit #2 - Matures 12/2/2023 - \$200,000.

--Grant Fund Money - Reinvest or Cash Out—Mr. Henley shared in discussion with Director Yanz and NIESA Office Manager, the ARP Grant Awarded has been spent which lowered the General Fund. It is recommended MSU Certificate of Deposit #2 in the amount of \$200,000 be moved to Action as Action Item B at the November 9, 2023, NIESA Board meeting.

Mr. Henley is recommending a Finance Committee meeting be scheduled to discuss MSU Certificate of Deposit options. NIESA board members have options including M-Class which is comparable to the CD rates at 5 percent (5%). Mr. Henley likes M-Class as you can park some money without being locked in for any length of time. Mr. Henley and the Finance Committee will consider NIESA's best position and will come back with a recommendation at the November 9, 2023, NIESA Board meeting.

2024 NIESA Meeting Schedule—NIESA board members shared the 2024 NIESA Meeting schedule looks good. It is recommended this item return for action at the November 9, 2023, NIESA Board meeting.

General Fund Budget 2024—Director Yanz shared the General Fund Budget for 2024 is not available for board review. It is recommended this item be brought back for discussion at our November 9, 2023, NIESA Board meeting.

Building & Equipment Budget 2024— Director Yanz shared the Building & Equipment Budget for 2024 is not available for board review. It is recommended this item be brought back for discussion at our November 9, 2023, NIESA Board meeting.

Public Hearing for 2024 Budgets—Director Yanz recommended a Public Hearing for 2024 Budgets not be scheduled until the 2024 Budgets are ready for board review. It is recommended this item be brought back for discussion at our November 9, 2023, NIESA Board meeting.

The Treasurer-NIESA board received Bank Balances/Investment Report/Bank Fees report. Mr. Henley shared at their Finance meeting they discussed MSUFCU-CD Rollovers, they will meet again to discuss options and will share their recommendation with board members at the November 9, 2023, NIESA Board meeting.

Committees-None

Director Yanz provided his Monthly Director's Report in the area of Administrative, Operations, Training, Grants, Personnel and other. Highlights were receiving the rubber stamp to use the \$1200 in grant money for the EMT Class scheduled for November 14, 2023, three (3) new paramedics and NIESA received the Michigan Fire Grant \$50,000!

Deputy Chief, Don Drent, shared the Ingham County Fire Academy began training 19 firefighters; 5 of them are from NIESA. Many new faces and different skillsets are on the horizon. The training runs from October 9, 2023, through April 2, 2024.

Also, a bill put forth by the Fire Marshall, would turn inspection of all assemblies and schools over to the local fire departments, State Fire Code NFPA 2015, state inspections on schools and assemblies with 50 or more individuals would be charged \$500 and for assemblies this would be an annual inspection. All fees collected for these inspections would go back to the state. Stay tuned.

Chairperson Hart provided a handout for the 2023 September 12th MTA Workshop Emerging Issues in Emergency Services held in Frankenmuth, Michigan. Highlights were:

- ✓ Simulation training trailer, family of manikins-travels over the state
- ✓ Community Integrated Paramedicine (Citizen assist? Refusal to transport?) NIESA has the refusal to transport covered.
- Mutual Aid Agreement, which one does NIESA have? NIESA has MABAS.

- ✓ Bureau of Fire Services recommendations Does NIESA have smoke alarms available to the community? Yes, NIESA has smoke alarms available to the community.
- ✓ Guns on the runs liability exposure Does NIESA have guns on runs – NIESA does not.

Chairman Hart will plan to attend the Village of Webberville Public Hearing on October 24, 2023.

Mr. Wilbrink has received many favorable comments on NIESA's response efforts and presence in the community and he would like to see a flyer prepared on NIESA Station #61 and Station #62s community efforts. It is recommended the flyer be and in the next round of tax assessments. NIESA needs to toot their own horn!
